V. Approval of Agenda

Mrs. Ayers noted that while listed under Action, the budget transfer request page [XII.g] is marked as Review. The clerk will correct this page and repost. No action is necessary by the Board.

On motion by Martha Harris, seconded by Kenneth Pritchett, the agenda for this meeting was unanimously approved.

VI. Approval of Minutes

On motion by Valarie Ayers, seconded by Sarah Barber, minutes of the regular meeting from September 21, 2017 were approved on a majority vote, with Mrs. Harris abstaining.

VII. Recognitions

Lexus of Richmond's week one nominee for the Leadership Award Scholarship is Lauren McCarey ('18-Chesterfield) of Maggie L. Walker Governor's School. With a 4.3 GPA, she scored a 1,530 out of a possible 1,600 on the SAT's. Lauren is a member of the National Honor Society as well as the Latin and English Honor Societies. She has scored 3 perfect 5's on AP tests and in 2017 she was named an AP Scholar with Honors.

As a four-year Varsity field hockey player, Lauren is currently the team captain for her senior season. In 2014 the team was the Virginia 4A State Runner-Up. Throughout her high school career, Lauren has collected accolades including All-State 2nd Team, All-Region 1st Team, Richmond Times Dispatch All-Metro 2nd Team, and All-Conference 1st Team. Additionally, Lauren has played defense for the Varsity soccer team since 2015, and she had previously been the JV soccer team captain.

Dr. Siddiqi arrived for the meeting.

VIII. Public Comments

The Public Information Period shall not exceed thirty (30) minutes. Each speaker will be allotted three (3) minutes to make his/her comments. Individuals representing groups will be allotted five (5) minutes.

Remarks provided and presented by Peggy Feldmann:

Good morning, school board members, superintendents, and faculty. I am Peggy Feldmann, the lead of PTSA Advocacy. I'd like to provide an update on funding as the state is moving into a new biennium. While the governor, secretaries and planning and budget are busy determining this year's governor's budget, the Department of Education's ingoing position was that the All Year Governor's Schools state funding will not include a 2.5% increase per-pupil attendance nor a \$50/student/course as these were add-ons to the 2017-2018 fiscal year budgets. This is a \$292,000 decrease for Maggie Walker. In the two years this money was available, the Regional School Board approved the hiring of a technology professional, a psychologist, leased a new bus, increased the athletic budget so parents would not continue to pay \$45,000 in operational costs, paid for waxing the gym floor instead of the parents, paid for graduation so the seniors and the PTSA did not have to pay the bill and bought replacement textbooks for many of the decade-old books. All of these were money well spent and should be in the normal operating budget of the school. A \$292,000 decrease will require a \$400/student increase by the localities for the school to avoid losing services or personnel. Since the \$200/student increase the Regional School Board has provided over the last few years has essentially only covered VRS and healthcare costs each year, more realistically, a \$600/student increase is required to maintain status quo. This means, even with a \$600/student increase in funding, there are no additional funds for the capital technology and facility plans or to save money for a replacement of the deteriorating track which has been discussed for years. Even with the \$292,000 additional dollars last year and the year prior, the school had so many needs that the budgeted track money was supplanted for higher priorities. And without a fully funded capital, technology, and facility plan, we are one infrastructure breakdown away in this 17-year-old remodeled, historic building.

Since all Governor's schools will be affected by this decrease, we anticipate this decrease in funding will be reinstated or made up with a different per pupil, state funding formula. Discussions are ongoing right now down at Capital Square. We urge each of you individually, or as a body, to move forward to have the 2.5% increase and \$50/student/course reinstated since the per course add-on amount is financially more equitable, for the full day, 7 or 8-course schools like Thomas Jefferson, Appomattox, and MLWGS. Even better, we would like the state funding increased to \$100/student/course. This is what Thomas Jefferson Governor's School would also request.

If the Governor puts forward a new state funding formula, it will probably come from the November 2016 DOE report. While that report was discussed here last year and establishes a bizarre formula that we do not support, it has one redeeming factor that Dr. Lewis pursued. Option 2 acknowledges, for the first time, that full-day schools do require more funding to operate than half-day schools. Should state leadership use this report for a new formula, we urge this board and superintendents to actively and aggressively pursue Option 2 and a 100% increase to the basic support of a student. The DOE report suggests that a 10% increase of basic support, or roughly an extra \$90,000 for Maggie Walker, is all that is required to operate a full day Governor's school as compared to a part day Governor's school. Maggie Walker is currently at a 60/40 split of local to state funding. This potential decrease in state funding drops that ratio to 65/35 local to state. In the DOE report, some part day Governor's schools are 100% funded by the state. And I think that all of your school districts receive more funding than a 60/40 ratio of local to state funding. Aggressively pursuing state dollars, so the school is funded as any

other high school, makes fiscal and logical sense. We urge the board and superintendents to actively pursue these increases in state dollars specifically for Maggie Walker, not just for your school district. Please use your leadership and your dedication to this school to financially and politically insert yourselves in the decisions of state funding of Governor's Schools.

Thank you very much.

The National Merit® Scholarship Program is an academic competition for recognition and scholarships that began in 1995. High school students enter the National Merit® Scholarship Program by taking preliminary SAT/National Merit Scholarship Qualifying tests (PSAT/NMSQT®) – a test which serves

as an initial screen of approximately 1.5 million entrants each year – and by meeting published program entry and participation requirements.

C. 2018-2019 Division Slot Letters

As MLWGS begins the planning process for the next school term as directed by Policy 1029 adopted May 18, 2000, amended December 18, 2014, and December 17, 2015, it annually seeks this slot commitment statement from participating divisions.

Letters were provided at the table for participating school divisions for their 2017-2018 student enrollment commitment. Letters were mailed to members not in attendance. Each letter should be executed by the division superintendent and school board member and returned to MLWGS by December 1, 2017.

D. MLWGS 2017 SAT and AP Scoring

Virginia’s 2017 public high school seniors outperformed their national peers in reading, writing, and mathematics on the revamped SAT. The College Board revised the college admissions test last year to better align the assessment with content students actually learn in high school and skills and knowledge identified as important to success in college.

Of the 51,613 Virginia public school 2017 graduates who took the SAT, 52 percent met or exceeded the SAT’s college-readiness benchmarks in both reading and writing, and mathematics.

Nationwide, 43 percent of SAT takers met the readiness standard on both sections of the test.

The 2017 SAT Virginia All-Schools Mean SAT Scores table below includes the performance of private, parochial and home-schooled students, as well as public high school seniors.

The College Board also reported that 48,108, or 67 percent, of the 71,940 Virginia public high school students who took at least one Advanced Placement examination during 2016-2017 earned at least one

score of three or higher, generally qualifying for college credit. Virginia public school students took a total of 143,221 AP exams during the year. Within College Board totals, 497 MLWGS students took 1,287 AP exams with 95% obtaining a score of three or higher.

The Director detailed personnel action noted in Folder B that included a club stipend to be filled in a 1/3 capacity each among three parents. Also, one substitute has been promoted to a .6 teacher.

XII. Action Items

a. Policy Amendment: 1010 MLWGS Constitution and Bylaws

The Regional School Board (RSB) and the Superintendent's Steering Committee tasked the Policy Steering Committee (PSC) with amending the annual meeting schedule for the RSB to consist of a maximum of six meetings.

The PSC has revised Policy No. 1010 – MLWGS Constitution and Bylaws to accommodate a six-meeting schedule (see Bylaws). The committee has also reinstated an Executive Board that shall have the full authority of the RSB with the exception of an amendment to the constitution and bylaws, approval of policy, modifications to the approved budget, issues that would require a closed session, or employment of the director. The Executive Board shall consist of five RSB members elected from its membership at the January reorganizational meeting for a one-year term. The Executive Board shall meet during those months the regular meetings do not occur, with the exception of the month of July.

The Director read parts of the red line version which was wordsmithed by the Policy Committee. One item he noted was the agenda section reading: 'if two executive board members are in disagreement with a voting item on the executive agenda, said item will be moved to the next Regional School Board meeting.' A question arose if two members of the Regional School Board have the pre-emptive authority to move an item from the Executive Board agenda to the RSB agenda. There being no discussion, the RSB determined to leave the language as written.

Mrs. Ayers asked if policy submission/approval and meeting minutes' approval and public posting will require a change to accommodate stretches of months between RSB meetings. Mrs. Ogburn stated the Executive Board should be empowered to approve minutes as all board members would have the opportunity to review them prior to approval; however, policy would have to wait or the RSB may have to call a regular meeting if it was a pressing matter. Mrs. Ogburn also suggested the policy committee could send proposals to board members in advance of meetings for their review. The Chair added his agreement that a full board meeting could be called to conduct timely business if needed. Mrs. Ogburn

sees a flexible meeting schedule that could exchange an Executive Board meeting with a Regional Board meeting and vice-versa.

On motion by Valarie Ayers, seconded by Sarah Barber, Policy 1010 – MLWGS Constitution and Bylaws Amended was unanimously approved.

b. Election of MLWGS Regional School Board Executive Board 2017

As stipulated in the Maggie L. Walker Governor’s School for Government and International Studies Constitution and By-Laws, Policy No. 1010, Article IV, Section 3:

An Executive Committee (the Executive Board), which shall have the full authority of the Regional Board in all matters except the amendment of the constitution and bylaws, approval of policy, modifications to the approved budget, issues that would require a closed session or employment of the Director. The Executive Board shall consist of five Regional Board members: The Chair or Vice-Chair and four other Regional Board members to be elected from its membership at the January reorganizational meeting for a term of one year. Terms of Executive Board members shall coincide with those of the Regional Board. The Regional School Board shall fill vacancies within the membership of the Executive Board if a member ceases to be a member of their local school board.

d) AP Comparative Government student field trip to visit key Canadian governing institutions and to meet with major Canadian political leaders. Students will learn about significant differences between a presidential and parliamentary system.

This trip will be comprised of ten (10) to sixteen (16) students and three (3) chaperones.

Estimated Total Trip Cost: \$25,500

Estimate per Student Cost: Not provided at this time

e) Combining tourism with study and broad-based travel with the development of personal relationships with locals, this trip represents a unique opportunity for students to become well acquainted with the Russian people and their history, architecture, religion, culture, and way of life. By combining the background knowledge gained in the seminars and readings with real-life, first-person examination and access to skilled, experienced Russian educators who are professionally and personally knowledgeable in precisely these fields, students will have a unique opportunity to experience Russian hospitality, appreciate the nation's history, and gain a profound and personally meaningful appreciation of Russian history and culture.

This trip is designed to accommodate eight (8) to twenty (20) students and one or two (1-2) chaperones.

Estimate per Student Cost: \$4,300

f) The Gender and Culture in the Middle East and North Africa (MENA) Senior Seminar explores the elements and evolution of cultures in the MENA region in the twentieth and twenty-first centuries. Morocco provides an excellent cultural pivot point by joining east and west; traditional and non-traditional; and allows students to explore a cultural amalgamation that is unique and shaped by geography, religion, and colonial experience.

This trip will be comprised of sixteen (16) students and four (4) chaperones.

Estimated Cost: \$2,630/student

h. Bullying Prevention Month

In an effort to promote awareness of school bullying, the Regional School Board has designated the month of October as Bullying Prevention Month.

WHEREAS, school bullying has become an increasingly significant problem in the United States and Virginia; and

WHEREAS, over twenty percent of the youth in the United States are estimated to be involved in bullying each year, either as a bully or as a victim; and

WHEREAS, an estimated one hundred sixty thousand students in kindergarten through twelfth grade miss school every day due to a fear of being bullied; and

WHEREAS, bullying can take many forms, including verbal, physical, and most recently in cyberspace, and can happen in many places on and off school grounds; and

WHEREAS, it is important for Virginia parents, students, teachers, and school administrators to be aware of bullying, and to encourage discussion of the problem as a school community; and

WHEREAS, the Regional School Board has developed policy on anti-bullying to encourage positive behaviors and to eliminate bullying behaviors including Policies 2065, 5030, and 8002; and

NOW, THEREFORE, the Regional School Board recognizes the month of October 2017 as Bullying Prevention Month, with the intention that the issue of bullying and its prevention be discussed in the classroom during that time.

Also, the committee discussed a specific DOE regulation with a sunset clause that could potentially cost all Governor’s Schools funding and specifically MW of \$292,000, but this is not yet set in stone and is in advance of the upcoming General Assembly session. However, this something we need to take note of and begin to approach from an advocacy standpoint. Dr. Gill remarked there is strength in numbers as opposed to approaching this development as a standalone school, but as a collaborative of Governor’s Schools.
