The following was submitted via an online comment form by Ian Miller from Hanover:

After learning that the admissions test that has previously been used by the Governor's School is not a good indicator of success in MLWGS, and after learnings that recent classes of students are under-representing people of color, I'm in favor of removing the admissions test on a permanent basis. I feel strongly that Governor's Schools should set an example for modern admissions policies that strive to represent their communities and afford opportunities to as many as possible.

The following was spoken and submitted in writing by Jackie Laundon

To the Executive Committee of the Maggie Walker Regional School Board:

Thank you for the opportunity to share these thoughts from the Anti-Racist Alumni Group, dedicated to helping our alma mater embrace strategies to improve and retain racial diversity among our students, faculty, and staff.

First, thank you for voting to suspend the admissions test for the incoming freshman class of 2021-2022. We hope by now that you and your respective school boards and superintendents have heard from many of the alumni who support that decision. As you know, Department of

Education Secretary Qarni's summer task force clarified that these admissions tests serve only to disparately impact Black and Latinx students. When privileged and resourced families pour money into test prep programs from around the world to master this type of test, it is no surprise that disparate outcomes would prevail. And as Dr. Lowerre and School Board Member Scott Barlow pointed out on October 15, the test is NOT a good measure of success here at Maggie Walker.

We hope that our letters show that you have the support of alumni to permanently eliminate the test after this year. We urge you to place this question of permanent elimination of the admissions test on your future agendas and join schools like Thomas Jefferson Science & Technology and other test-based high schools around the country, who are likewise eliminating their test.

Second, we understand that during its last meeting, the Strategic Planning Implementation Team explored the topic of hiring a diversity coach or consultant. We urge the School Board to explore the creation of a permanent staff position dedicated to leading the school's efforts on diversity, equity, and inclusion ("DEI"). We believe the school's new strategic plan should include this position. But we realize that this takes time, approval, and funding.

In the interim, please know that the alumni of this group are more than happy to step up financial support to expand current efforts that bring DEI education to Maggie Walker. We understand, for example, that the Virginia Center for Inclusive Communities has presented on DEI to several students. We want to support more opportunities like that not just for students, but also for faculty and staff in their professional development. As alumni, we know how to fundraise through the Foundation to support important initiatives of the school, and this is an initiative we want to support. We ask that this be added to your agenda and to your new strategic plan.

These two initiatives—(1) permanent elimination of the admissions test, and (2) hiring a dedicated diversity equity and inclusion specialist for the school—would equitably widen the doors to Maggie Walker and sustain our region's diverse talent.

To cultivate the next generation of global leaders, Maggie Walker must ensure that those who have the opportunity to receive this world-class education reflect our region's talent--from all walks of life. Our Black and Latinx students should be part of that tapestry in larger numbers, and these strategies would be an effective start to making them a meaningful part of that vision.

IX. Director's Report


A. Verbal Updates

Virtual Information Sessions for Prospective Families, November 9, 2020
 MLWGS will be providing virtual content instead of the in-person information nights that usually occur in November. A webpage will be created that will contain narrated presentations as well as student videos and links to additional resources.

The MLWGS team has participated in many virtual recruiting nights as well as one in-person throughout October. We appreciate the support of the local districts in providing information about MLWGS during these difficult times.

Dr. Lowerre would not be surprised to see lower than normal application numbers with this upcoming admittance class due to the lack of opportunities for families to visit the school.

 MLWGS students outperformed their peers nationally and in Virginia by a significant margin on the ACT college-admissions test from the last results available from the Class of 2019. The MLWGS composite score was 31.5, while the national composite score was 20.9 and the Virginia composite score was 24.

Maggie L. Walker Governor's School 2020 SAT Achievement vs Virginia and National Public School Mean Scores


MLWGS graduates outperformed their nationwide and Virginia peers on the SAT in 2020, according to data released by the College Board, the non-profit organization that administers the college admissions test. Overall, Virginia high school seniors achieved an average combined score of 1116, which was 65 points higher than the national average, while Walker students scored a combined 1400, an impressive 349 points higher than the national average.

Of the 58,485 Virginia 2020 graduates who took the SAT, 55% met or exceeded the College Board's college-readiness benchmarks in both reading and writing and mathematics. Nationwide, 45% of SAT takers met the readiness standard on both sections of the test.

Sixty-five percent of Virginia's 2020 graduates took the SAT, making it by far the most popular college admissions test in the commonwealth. Approximately 2,700 fewer Virginia graduates took the SAT due to the curtailment of spring SAT testing because of the coronavirus pandemic.

X. Unfinished Business

A. Strategic Plan Implementation Report

The report is located at the end of these minutes.

The director added in his review that today's speaker did a good job of touching on the report in her remarks. The report includes target dates and responsible parties for its goals and objectives, but the current budget does not allow the school to bring on a full-time DEI position. However, there may be flexibility to hire an outside consultant for a neutral review along with possibly seeking financial assistance from the GS Foundation to make this happen.

Dr. Lowerre indicated the implementation team is meeting about once per month virtually and is comprised of diverse stakeholders. He stated he believes the team has a good handle on what they need to do to try to create an environment where students feel welcome at MLWGS.

B. Annual Notice of School Advisory Council Membership 2020-2021

It is the duty of the Regional School Board to appoint advisory councils or committees of citizens of the school for consultation regarding specific matters pertaining to Maggie L. Walker Governor's School. These committees shall serve without compensation for one-year terms.

Composition Membership of the SAC may consist of parents, staff, and students of MLWGS, corporate and community members, alumni, higher education representatives, school administrators, and gifted program specialists. Membership should reflect the diversity of the community in terms of school district size and underrepresented minority groups. The Regional School Board (RSB) shall be notified annually of the SAC membership.

The Chair asked what was the selection process for members especially for students, noticing they all are from Chesterfield. The director's appointee Max Smith responded to this question by describing the process. For students, it is a 2-year term, with sitting SAC members reaching out to the student body to encourage their application. There are interviews followed by selection, so it starts with a broad net and ends with students who are excelling academically and engaged with the school.

Ms. Barber suggested if we do not have representation from the smaller divisions, we reach out to them offering encouragement to submit applications. Mr. Smith indicated those attempts are made, but the committee historically has found transportation to be an issue for them.

XI. Consent Items

XII. Action Items

a. Request for Admission in AY22 by Dinwiddie Public Schools (Waive First Read Requested)

The director received a request by Dr. Kari Watson, Dinwiddie Public Schools Superintendent, requesting to rejoin the MLWGS partnership with students in the 2021-2022 academic year as required by the Constitution (see Article III for the applicable section below).

ARTICLE III

Section 1 – Membership of Organization

The membership of this Organization shall be composed of the participating School Boards of Charles City County, Chesterfield County, Goochland County, Hanover County, Henrico County, Hopewell, King and Queen, New Kent County, City of Petersburg, Powhatan County, Prince George County and the City of Richmond.

Section 2 – Addition/Deletion of Participating School Boards

School Boards wishing to participate in the Maggie L. Walker Governor's School shall make an application in writing to the Regional School Board requesting admission. An application must be made prior to the second semester of the academic year in order for student slots to be allocated for the subsequent academic year. An affirmative vote by a majority of the Regional School Board will constitute acceptance of the application.

b. Student Return to Campus Instruction

After taking into consideration the different plans of our partner districts, the challenge surrounding the transportation of our students, and the current health conditions related to the Covid-19 pandemic, the director recommended to the Executive Committee of the Regional School Board for MLWGS to work toward bringing students back for in-person learning on February 1st, 2021.

This is not a decision that we have taken lightly. The director stated, "I am acutely aware of the hardships of staying in a virtual learning environment as well as the challenges that many have expressed regarding returning to campus too soon. However, I feel that it is important to establish a target date and work toward solving the many problems that go with returning to campus so that the transition is as smooth as possible."

The director shared the results of a survey that was sent to our families:

454 responded out of 754

- 74.2% wish to return to in-person learning
- 25.8% wish to remain virtual

The majority by far of students that wish to remain virtual live in Henrico County and the City of Richmond

Of the 74.2% (337 students) that want to return, 8.8% (40 students) would not have transportation if their district was unable to provide it.

Our survey to the staff yielded the following data:

77 responded out of 92

- 72.7% would return if CDC and VDH guidelines are followed
- 27.3% would request to remain virtual due to documented health reasons (9.1%) or other issues such as taking care of elderly parents or immunocompromised children (18.2).

To summarize, with about 49% of our students living in districts that are staying out until the start of the 2nd semester and the issue of transportation, and potentially having to find coverage for roughly a quarter of our staff, it just doesn't seem possible with our limited resources to open at the start of the second marking period. Additionally, while we aren't directly affiliated with RPS, our physical location is within the City of Richmond where the pandemic has disproportionally affected its residents. Given the regional nature of our school and the ability to potentially spread the virus over a larger area, it seems that a cautious approach is warranted.

Over the next few weeks, we will begin to develop and share a plan for how instruction will be delivered and what the expectations for all stakeholders will be. While the February date is a goal, it could change depending upon pandemic conditions and the decisions of our partner districts. However, the director stated he believes that it is important to set a goal with a date to provide some degree of hope for our learning community. It will also allow us to establish a timeline to prepare for the arrival of students if we can welcome them back in February.

On a motion from John Wright, seconded by Harwood Hall, the request to establish February 2021 as a goal to return students to in-person campus instruction was unanimously approved on a roll-call vote.

- The chair advised that all members of the board are receiving letters from alumni indicating their support for changes to the admissions process. In discussion with Ms. Barber, they agreed it was appropriate to respond to the alumni that the board has received their communication and is hearing their concerns.
- Secondly, the chair indicated her appreciation for Dr. Lowerre 's service during these unique and difficult times given the board is not there in-person for support, and stated there are probably times he feels completely alone in these decisions. She added if the director needs for any of them to meet as a group or individually or even at a special session meeting, feel free to call on us. Dr. Lowerre expressed his appreciation for the boards' support.
- CARES Act funding for PPE was questioned. Dr. Lowerre stated so far the funding is covering school needs. Mr. Smith stated a large amount of those funds have been directed to technology to help students with laptops and mobile hot spots and for teacher professional development to assist them with virtual instruction. The rest has been directed to the purchase of Plexiglas, masks, hand sanitizer, gloves, etc. Also, Max will look into an air purification system for the school based on Mr. Wright's suggestion. The Chair offered division assistance if needed for Maggie Walker GS.
